**RESOLUTION RECOMMENDING APPOINTMENT OF CREIGHTON
REGENWETHER AS STREET AND SOLID WASTE SUPERINTENDENT OF THE
CITY OF CLINTON, IOWA**

WHEREAS, the position of Street and Solid Waste Superintendent is a budgeted position in the budget ending June 30, 2016, which is necessary and vital to the operations of the City of Clinton; and

WHEREAS, the position was approved as part of a reorganization to a Parks and Recreation Department and a Street and Solid Waste Department on Resolution 2015-447; and

WHEREAS, it is the recommendation of the City Administrator that Creighton Regenwether, be named the Street and Solid Waste Superintendent of the City of Clinton; and

WHEREAS, this position will be included in Pay Grade 7, Step 3 at a salary of \$61,737, with commensurate out of rank pay of \$179.56 per pay period for department head-related duties;

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CLINTON, IOWA that Creighton Regenwether, is hereby named the City of Clinton Street and Solid Waste Superintendent; and

BE IT FURTHER RESOLVED THAT this appointment shall be effective as of January 19, 2016.
